Summary : OPD initiated a traffic enforcement stop on a blue, 2016 Hyundai Elantra for a cell phone violation. When Officers approached the vehicle, the driver fled northbound on Porter Ln. The vehicle failed to yield and a pursuit was initiated. The vehicle failed to stop at the stop sign and drove E/B onto W Walker St, S/B onto Eighth St, E/B onto Colusa St, and S/B onto Sixth St. The speed of the vehicle was estimated to be in excess of 60 MPH. The driver failed to stop for a red traffic light and drove E/B onto South St, N/B onto Marin St, and E/B onto Chapman St. Officers lost sight of the vehicle and terminated the pursuit. The driver fled from the vehicle and a citizen called to report seeing the suspect running northbound through residential yards. Officers and GCSO Deputies established a perimeter and the suspect, identified as 32 y/o Orland resident John Talmadge was taken into custody without further incident. During the course of the investigation Officers learned the vehicle was stolen from Talmadge's estranged wife and Talmadge had 4 felony warrants for his arrest. Talmadge was booked into the Glenn County Jail for felony evading, vehicle theft, possession of stolen property, driving while his license was suspended for a prior DUI, and 4 felony warrants. The vehicle was released to the registered owner.
