The vehicle stopped and the occupants, 35 y/o Candi Adams and 32 y/o Adam Hutcheson, both of Chico, were detained. During the investigation Deputies located a loaded handgun that was thrown from the vehicle. After further investigation, Hutcheson was arrested for being a prohibited person in possession of a firearm and possession of a controlled substance. Hutcheson suffered from a medical emergency and was released from custody to receive treatment at a local hospital. A report will be forwarded to the District Attorney for further review.
